#### CLUB EXCELLENCE AWARD

To qualify, the Club must further the objectives of the Association, adhere to the Association's Constitution and By-Laws and Policies, and meet each requirement noted below during the fiscal year.

Submit the following requirements along with the Club name, number, 2016-2017 President's Name, their Member Number, and Zone to the District Governor prior to September 20, 2016.

#### **REQUIREMENTS:**

- 1. Club must be in good standing with District, State and Lions Clubs International.
- 2. Conduct at least three (3) Service Projects. (Please furnish date and activity).
- 3. Contributions: The Club must have paid the Governor's 100% Voluntary Contributions.
- 4. Membership: The Club must achieve a net growth in membership of 7 members or 10% whichever is greater. This may include Branch Clubs if applicable. The new members attend an orientation and were properly inducted into the Lions Club.
- 5. Communication: Please explain briefly how the Club service activities were published: Newspaper articles, Public Service Announcements, and other forms of local media.
- 6. Leadership Development: All officer positions were filled in accordance with the Constitution and By-Laws by qualified Lions. A majority of the Club officers Participated in leadership training programs at the Zone, District, State, or International level and Club was represented at Zone meetings.

- 7. Club Development: The Club has hosted regular and meaningful Club Meetings and submitted the Monthly Membership Report. The Service Activity Report, and the Club Officer Report (PU101) **must be submitted in a timely manner.**
- 8. One shipment of used eyeglasses sent to:

Texas Lions Eyeglass Recycling Center 2550 Flynt Midland, TX 79702

- 9. Three (3) or more members attend two (2) or more District Cabinet Meetings.
- 10. Club Meetings include at least four (4) Programs on Lions Charities.

#### **GOVERNOR'S 100% VOLUNTARY CONTRIBUTIONS**

Each District Governor establishes a list of Lions' charities deemed to be worthy of club consideration for contributions. These are voluntary and not considered part of the club dues structure. A club should consider any or all of the recommendations after all local needs have been determined.

At the Lion's years end all 100% clubs will be awarded a banner patch in recognition of their voluntary contributions.

Separate checks should be written to each charity. The checks should be sent to District 2-TI Cabinet Treasurer, Kevin Cox, 1025 Sterling, Amarillo, TX 79110.

Contributions will be recorded and checks forwarded to respective charities.

### Council of 2020 -2021 Polar Bear Challenge

Your Council has the honor of kicking off the biggest project at TLC since the inception of the camp – CAMPaign Vision 2020 & Beyond, a campaign to replace our bunkhouses, care-taker quarters, and basic infrastructure. This is sorely needed if our camp is going to be relative for another 70 years...... AND to kick things off, the Texas Lions Camp was selected by Mo Ranch to be the beneficiary of the 2021 Polar Bear Challenge on January 1, 2021. We hope you will use this honor given to our camp to make TLC & "CAMPaign Vision 2020 & Beyond" a major part of your District Governor Year.

We likely won't get chosen for this honor again for many years, but it gives us a perfect opportunity to get all our Lions thinking about our new "vision" for TLC's future.

So how does this work? Simple: you raise money from individual Lions, Lions & Leo Clubs, friends and patrons in the name of someone, whom you would really LOVE to see – in this case ME – take a freezing plunge down a long slide into the extremely frigid Guadalupe River next January 1<sup>st</sup>. Even better, since our President & CEO, Stephen Mabry, was kind enough to put me on the Polar Bear Challenge "Royal Court", I am blessed with the opportunity to win some "awards" (tongue in cheek). For example, if I am the biggest fundraiser, I will be crowned the King --- I think that might mean I have to take the plunge several times!

Anyone is actually able to come and watch on January 1<sup>st</sup> or better yet, anyone can take the plunge by raising their own funds (or paying \$25). If you put your minds to it, I'm sure the Council of 20-21 can come up with some challenges between the District Governors to make this more interesting – losing Governor to take the plunge in a tutu, or lowest 8 Governors buy steak dinners for the highest 8 Governors.

Usually the Polar Bear Challenge raises \$30 to \$40K because the beneficiaries are more local in reach than TLC. Last year the Hill Country Youth Ranch raised \$70K, which is the best ever. TLC not only has Kerrville, but all the Lions & Leos across Texas. This especially has "Campus Clubs" written all over it. We're shooting for \$250,000!!

Let's start our CAMPaign .....with a BANG!



The person on the Polar Bear Challenge Court, who raises the most money, will be crowned KING for the 2021 plunge into the freezing Guadalupe on January 1<sup>st</sup>. Money donated to the challenge will go directly to the Camp in the name of the poor Eskimo you'd love to see turned into an ice cube on January 1<sup>st</sup>. All donations should be clearly marked as Polar Bear Challenge, the District name and the "honoree".

I know you'd love to see some hot-headed old PCC/PDG (who would love to tell you "how we did it when I was Governor"), get cooled off in the river. So, here's the challenge:

If I am made king of the court, I will add \$500 to the total of the District that had the highest donations in my name. In addition, the District Governor of the District will get to design the costume that I will wear while

taking the plunge (as long as they do not include anchors , concrete blocks, or anything else designed to keep a good Lion "down"!
